NF declared their non-pecuniary position on the board of DAPTC. Fire Stations: NE explained a grant from government had prevented the closure of 8 fire stations in Dorset and Wiltshire for 12 months but the future was by no means secure. Proposals are being put forward to keep the stations open in the longer terms and what action is required including an increase in council tax.

A comprehensive strategic review is needed in the near future.

Maiden Newton flooding: Dorset Council are conducting a flood review made more difficult by a reluctance to report flooding. Any action taken must guarantee no detriment to locations upstream and there is £1.3m available for specific projects for these areas.

Trailway and Rights of Way Improvement Plan: the Trailway is included at a high level in an upcoming survey that residents and councils are encouraged to complete. NF stated the council's frustration with the lack of action on the Toller Porcorm to Maiden Newton section when all parties are in agreement to open the route.

Planning: NE has concerns over an upcoming government proposal to have a national scheme of delegation. This would remove the ability of local authorities to call applications to committee for review.
